Upon the advice of our auditors, three policies were passed at the Business Meeting in January. I want to emphasize that these policies were requested due to new questions being asked on our annual tax return. They were not in response to any problems or suspected problems with any officer or member.

1. **Conflict of Interest Policy:** All officers and trustees must report to the Grand Knight on an annual basis any potential conflict of interest between their personal interests and those of the Knights of Columbus. It will be the responsibility of the Grand Knight to enforce this policy.
2. **Whistleblower Policy:** It shall be the duty of each member of the Knights of Columbus to report

privately to the Grand Knight any impropriety taking place in any area or activity of the organization. The Grand Knight will investigate all such reports.

3. **Retention and Destruction Policy:** All financial documents used in preparing annual audits will be maintained for a minimum of seven years. All other documents will be maintained for a minimum of one year.

Also, under the direction of Grand Knight John Haug, we are doing a better job of living within our reduced level of income. Keep up the good work.
